NOTICE IS HEREBY GIVEN THAT THE FOLLOWING ORDINANCES WERE INTRODUCED AND PASSED ON FIRST READING AT A MEETING OF THE MAYOR AND COUNCIL OF THE BOROUGH OF LITTLE FERRY, HELD ON NOVEMBER 13, 2025 AND THAT A MEETING OF SAID MAYOR AND COUNCIL TO BE HELD AT THE MUNICIPAL BUILDING, 215-217 LIBERTY STREET, LITTLE FERRY, NEW JERSEY, ON DECEMBER 2, 2025 AT 7:00 P.M. OR AS SOON THEREAFTER AS THE MATTER MAY BE HEARD, SAID ORDINANCES WILL BE FURTHER CONSIDERED FOR FINAL PASSAGE, AT WHICH TIME AND PLACE ALL PERSONS WHO MAY BE INTERESTED THEREIN WILL BE GIVEN AN OPPORTUNITY TO BE HEARD CONCERNING THE SAME. ORDINANCE NO. 1657-21-25

CAPITAL ORDINANCE PROVIDING FOR THE PURCHASE OF BREATHALYZER PARTS AND EQUIPMENT FOR THE POLICE DEPARTMENT IN AND BY THE BOROUGH OF LITTLE FERRY, IN THE COUNTY OF BERGEN, NEW JERSEY, APPROPRIATING \$22,823.00 THEREFOR FROM THE CAPITAL IMPROVEMENT FUND AND D.D.E.F. FUNDS AS AUTHORIZED BY THE NEW JERSEY OFFICE OF THE ATTORNEY GENERAL

BE IT ORDAINED, by the Borough Council of the Borough of Little Ferry in the County of Bergen, New Jersey (not less than two-thirds of all members thereof affirmatively concurring), as follows:

SECTION 1.

The improvements described in Section 2 of this Ordinance are hereby respectively authorized as general improvements to be made by the Borough of Little Ferry, New Jersey. For the said improvements or purposes stated in Section 2, there is hereby appropriated the sum of \$22,823.00, said sum being inclusive of all appropriations heretofore made therefor and available for said purposes, of which \$15,823.00 shall be provided from the Capital Improvement Fund and \$7,000.00 shall be provided from D.D.E.F. (Drug and Driving Enforcement Fund) monies as authorized by the New Jersey Office of the Attorney General.

SECTION 2.

The Borough of Little Ferry, in the County of Bergen, State of New Jersey, is hereby authorized to provide for the following:

SECTION 3.

It is hereby determined and stated:

(a) That said purposes are not a current expense, but are improvements that the Borough may lawfully make, and that no part of the cost thereof shall be specifically assessed on properties specially benefited.

(b) It is not necessary to finance said appropriations by the issuance of obligations by the Borough of Little Ferry pursuant to the Local Bond Law of the State of New Jersey, as sufficient monies to cover the appropriations shall be available from the Capital Improvement Fund in the amount of \$15,823.00 and from D.D.E.F. funds in the amount of \$7,000.00.

SECTION 4.

The Capital Budget of the Borough of Little Ferry is hereby amended or established to conform with the provisions of this Ordinance to the extent of any inconsistency herewith. The resolution in the form promulgated by the Local Finance Board showing all detail of the amended or temporary Capital Budget and Capital Program as approved by

the Director of the Division of Local Government Services is on file with the Clerk and available for public inspection.

SECTION 5.

The total sum of \$22,823.00 is hereby appropriated for the aforementioned purposes in accordance with the funding sources detailed herein.

SECTION 6.

It is hereby determined and stated that no supplemental debt statement is required to be made and signed in connection with said appropriations, since the gross debt of the municipality, as defined under the Local Bond Law, is not increased by this Ordinance and no obligations in the nature of notes or bonds are authorized hereby.

SECTION 7.

This Ordinance shall take effect after publication thereof and final passage as required by law.
