NOTICE is hereby given that the following ordinance was introduced and passed on first reading at a meeting of the Mayor and Council of the Borough of Little Ferry, held on January 2, 2026 and that at a meeting of said Mayor and Council to be held at the Municipal Building, 215-217 Liberty Street, Little Ferry, New Jersey, on February 10, 2026 at 7:00 p.m. or soon thereafter as the matter may be heard, said ordinance will be further considered for final passage, at which time and place all persons who may be interested therein will be given an opportunity to be heard concerning the same. ORDINANCE NO. 1660-02-26

A CAPITAL ORDINANCE APPROPRIATING THE SUM OF \$103,988 FOR IMPROVEMENTS TO SABINA STREET TO BE UNDERTAKEN BY THE BOROUGH OF LITTLE FERRY AND TO APPROPRIATE \$103,988 FOR THE SAME.

BE IT ORDAINED, by the Borough Council of the Borough of Little Ferry in the County of Bergen, New Jersey (not less than two-thirds of all members thereof affirmatively concurring) as follows:

SECTION 1. The improvements described in Section 2 of this Ordinance are hereby respectively authorized as general improvements to be made by the Borough of Little Ferry, New Jersey, for the said improvements or purposes stated in Section 2, there is hereby appropriated the sum of money therein stated as the appropriation made for said improvements or purposes, said sum being inclusive of all appropriations therefore made thereof and amounting in the aggregate to \$103,988 which will be funded by the following grant proceeds within the capital improvement fund listed below.

SECTION 2. The Borough of Little Ferry, in the County of Bergen, State of New Jersey, is hereby authorized to provide for the following:

Community Development Block Grant:	
Sabina Street Road Improvements	103,988
Total Appropriation and Estimated Costs	<u>\$103,988</u>

SECTION 3. It is hereby determined and stated:

- (a) That said purposes are not a current expense. That the same are improvements which the municipality may lawfully make and that no part of the cost of said improvements has been or shall be specifically assessed on properties specifically benefited.
- (b) It is not necessary to finance said appropriations by the issuance of obligations by the Borough of Little Ferry pursuant to the Local Bond Law of the State of New Jersey, for the reason that monies sufficient to cover the appropriations thereof shall be available from grant proceeds within the capital improvement fund in the amount of \$103,988 .

SECTION 4. The Capital Budget of the Borough of Little Ferry is hereby amended or established to conform with the provisions of this Ordinance to the extent of any inconsistency herewith. The resolution in the form promulgated by the Local Finance Board showing all detail of the amended or temporary Capital Budget and capital program as approved by the Director of the Division of Local Government Services is on file with the Clerk and is available for public inspection.

SECTION 5. The sum of \$103,988 is hereby appropriated for the aforementioned purposes.

SECTION 6. It is hereby determined and stated that no supplemental debt statement is required to be made and signed in connection with said appropriations, since the gross debt of the municipality, as defined under the Local Bond Law, is not increased by this Ordinance and no obligations in the matter of notes or bonds are authorized by this Ordinance.

SECTION 7. This Ordinance shall take effect after publication thereof and final passage as required by law.
