# BOROUGH OF LITTLE FERRY STATE OF NEW JERSEY ORDINANCE NO. 1653-17-25

# AN ORDINANCE AMENDING CHAPTER 2, SECTION 2-24.3, ENTITLED "APPOINTMENTS TO THE DEPARTMENT; TESTING; PREQUALIFICATIONS" OF THE REVISED GENERAL ORDINANCES OF THE BOROUGH OF LITTLE FERRY, COUNTY OF BERGEN AND STATE OF NEW JERSEY

BE IT ORDAINED by the Mayor and Council of the Borough of Little Ferry, that Chapter 2, Section 2-24.3(d)(2)(a) of the Ordinances of the Borough of Little Ferry is hereby amended and shall be read as set forth below and that those portions of the Ordinance not set forth below shall remain unchanged.

Section 2-24.3(d)(2)(a)

No fewer than 6 and no more than 10 applicants shall be subject to an interview by the Mayor and Council whereby, after said interviews are considered, the Mayor and Council shall rank the applicants from 1 through 10.

### REPEALER

All Ordinances or parts of Ordinances inconsistent herewith are repealed as to such inconsistencies.

### **SEVERABILITY**

If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions thereof.

# EFFECTIVE DATE

This ordinance shall take effect upon passage and publication as provided by law.
