NOTICE IS HEREBY GIVEN THAT THE FOLLOWING ORDINANCES WERE INTRODUCED AND PASSED ON FIRST READING AT A MEETING OF THE MAYOR AND COUNCIL OF THE BOROUGH OF LITTLE FERRY, HELD ON OCTOBER 14, 2025 AND THAT A MEETING OF SAID MAYOR AND COUNCIL TO BE HELD AT THE MUNICIPAL BUILDING, 215-217 LIBERTY STREET, LITTLE FERRY, NEW JERSEY, ON NOVEMBER 13, 2025 AT 7:00 P.M. OR AS SOON THEREAFTER AS THE MATTER MAY BE HEARD, SAID ORDINANCES WILL BE FURTHER CONSIDERED FOR FINAL PASSAGE, AT WHICH TIME AND PLACE ALL PERSONS WHO MAY BE INTERESTED THEREIN WILL BE GIVEN AN OPPORTUNITY TO BE HEARD CONCERNING THE SAME. COPIES OF THESE ORDINANCES HAVE BEEN POSTED ON THE BULLETIN BOARD UPON WHICH PUBLIC NOTICES ARE CUSTOMARILY POSTED IN THE MUNICIPAL BUILDING OF THE BOROUGH OF LITTLE FERRY AND ON THE BOROUGH'S WEBSITE, AND COPIES ARE AVAILABLE UP TO AND INCLUDING THE TIME OF SUCH MEETING TO THE MEMBERS OF THE GENERAL PUBLIC OF THE BOROUGH OF LITTLE FERRY WHO SHALL REQUEST SUCH COPIES, AT THE OFFICE OF THE BOROUGH CLERK IN SAID MUNICIPAL BUILDING IN THE BOROUGH OF LITTLE FERRY, NEW JERSEY.
